## **Board Vacancies**

In December 2011, three board terms will expire. The Audiologist position on the board will be open. Stephen Harris has served two consecutive terms and at this time is not eligible for reappointment. The position of Speech-Language Pathologist certified by BESE and employed in a school-setting is currently filled by Theresa Rodgers. Ms. Rodgers has served two consecutive terms and at this time is not eligible for reappointment. The Speech-Language Pathologist position, filled by Kerrilyn Phillips, will expire. Ms. Phillips is eligible for reappointment.

Members of the board are appointed by the governor for terms of three years each or until their successors have been appointed and take office. The Louisiana Speech-Language-Hearing Association (LSHA), within not less than thirty days prior to the expiration of each

term of office, submit to the governor a list of at least three names for each respective professional service category of board member, except the physician member and the public member, selected by all licensed speech-language pathologists and audiologists in this state, from which the governor shall make his appointment to fill the office for the next succeeding term. No person is eligible to serve for more than two consecutive three-year terms. All members appointed by the governor shall be confirmed by the Senate.

The board typically meets six times a year. Open meeting laws require that a quorum of the board meet face-to-face to conduct business. A quorum of the board is at least four members. No member of the board shall be paid any compensation for duties performed as a member of the board, but shall be reimbursed for all reasonable and necessary travel expenses in attending any meeting of the board within this state and may be reimbursed for all other reasonable and necessary expenses incurred in attending meetings of the board or on necessary business of the board which is authorized by the board.

Persons interested in serving on the board should respond to the "Call for Nominations" that will be published by LSHA later this year.

The Board is again offering a waiver of the \$3.00 credit card processing fee for timely online renewals, to include those processed between April 15th and June 30th, to encourage individuals to renew online. ### **Continuing Education Categories: RELATED OR IN THE AREA?**

Many of us acquire all of the continuing education (CE) clock hours required for licensure renewal through attendance at a professional conference such as LSHA, SPALS, AAA, or ASHA. Licensees frequently assume that because their ten clock hours were completed at a conference hosted by a speech-language pathology and/or audiology association, that all of the CE hours are automatically in the area of licensure. This is not necessarily the case.

**Even** when attending prestigious high-quality conferences, not every session will necessarily address the provision of clinical services. Each conference session, workshop, distance learning course, employer-sponsored training, or other continuing education activity must be critically analyzed and categorized when completing the continuing education summary form (or on-line continuing education section) at the time of licensure renewal.


In the fall of 2009, one of the sessions I attended at the SPALS conference was "I Used to Have a Handle on Life but It Broke". This same presentation was an invited session at a previous ASHA Convention. While the session was presented by a well-known, highly skilled presenter who is a speech-language pathologist, it was about organizational, management, and coping strategies for our professional and personal lives. This is an example of continuing education that is "related" rather than "in the area" (of licensure).

Have you ever attended a workshop thinking that the session was going to provide information on speechlanguage pathology or audiology only to have the session address information in much more general terms? To provide an example of how a topic can sometimes be "in the area" and sometimes be "related", consider the topic of IEP development or IEP writing. A workshop provided to all special education staff members on the basics of IEP writing including how to utilize the SER (Special Education Reporting) web-based application for development of IEPs is not in the area of audiology or speech-language pathology. However, a workshop for speech-language pathologists such as "Meeting the Needs of Students with Speech or Language Impairment through Quality

IEP Development" would be "in the area" as the content directly relates to descriptions of current functioning in the area of communication, how the communication disorder impacts the student, how to develop or target goals for improvement of communication, etc.

LBESPA Rule 123.B. stipulates "Of the 10 hours, five shall be in the area of licensure (practice of audiology or speech-language pathology), and five may be in areas related to the professions of audiology and speechlanguage pathology". To clarify, a licensee may obtain all ten required hours in the area of licensure, but only five hours of training in related areas may be utilized toward the ten required clock hours of continuing education. Prior to submitting the CE Summary Form to the Board, or completing the CE section of the on-line renewal form, it is critical that each licensee analyze the topic and content relative to clock hours earned.

# Mentoring Students Into The Profession Remodillips, SERD, COCSEP

The students in university training programs prepare for years and go into debt in order to become a speech-language pathologist or audiologist. Practicing professionals recognize that training someone to become part of a profession requires more that attending class and gaining clinical practicum hours. It takes hard work on the part of faculty, internal and external supervisors, and students. Training future professionals requires participation from the Dean of a Graduate School to the licensed professionals engaged in practice. Individuals along the way must be willing to listen and develop future colleagues by coaching, guiding, and advocating for the profession. In essence, development is dependent on mentors.

Successful people indicate that one of the most important factors to their success is having a mentor. Successful people state that each professional has a responsibility to teach future professionals how to navigate our professional culture by sharing our wisdom. The Clinical Fellowship is designed as an opportunity to further engage in mentoring during the transition from graduate student to professional.

As the Coordinator of Graduate Program in Speech-Language Pathology and a faculty member at Louisiana Tech University, I have adopted a teaching philosophy that is grounded in leadership development. One of the key factors in developing and retaining students is to offer growth and development opportunities. Allowing a student to attend external seminars, workshops, professional meetings, in my opinion exposes students to the differing viewpoints and challenges that exist within the profession.

While serving on the Licensure Board, it has become obvious that issues being discussed by the Board are excellent real life teaching experiences to supplement Professional Issues courses. Thus, I invite faculty, graduate, and undergraduate students to attend Licensure Board meetings. Since all Board meetings are open to the public, except for Executive Session, there should be no fear that confidential information is being shared.

Students who have attended Board meetings report benefits such as: heightened career awareness, increased ability to make better decisions, better attitudes about school, and of course, the lure of getting out of the classroom. The benefits that I have personally gained include: connecting with future colleagues, opportunities to enhance and develop new skills, and the satisfaction of contributing to the professions. Benefits to the university include: increased community support, promoting the university, and opportunities to enhance the classroom experience.

The effectiveness of mentoring depends largely on the individual needs of the student and the mentor. The profession must continue to develop and promote our most important resource—students in training.

Notice is hereby given in accordance the provisions Administrative Procedure Act, R.S. 49:950 et seq., and through the authority granted in R.S. 37:2656(c), that the Louisiana Board of Examiners for Speech-Language Pathology and Audiology intends to update the Rules, Regulations and Procedures to reflect current requirements set forth by universities to obtain undergraduate and graduate degrees, to clarify the sections regarding supervision requirements, to implement rules specific to individuals who reapply after their license has been lapsed for ten years, to revise the current code of ethics to have language specific to masters level practitioners and language specific to bachelors level practitioners. Lastly, the board is requesting other "housekeeping" type amendments to revise the language, but not the intent of the rule.
